Diabetes Management Program Expansion

Today is American Diabetes Association Alert Day! It is a 1-day wake-up call to inform the public about the seriousness of diabetes, mainly when diabetes is left undiagnosed or untreated.

TakeCare's Wellness Program provides evidence-based Diabetes Programs to help patients develop the skills necessary to make better self-management decisions.

TakeCare's Wellness Program offers the following Diabetes Programs:

National Diabetes Expansion Program (NDPP) – TakeCare's Diabetes Prevention Program (DPP) is fully recognized and complies

with the Centers for Disease Control and Prevention (CDC) nationally recognized structured lifestyle change program—developed specifically to prevent type 2 diabetes.

Diabetes Management Class – This one crash course session is intended for members who are newly diagnosed with diabetes or members with diabetes who have not had a diabetic teaching in the past. It provides patients an overview of disease process and basic management strategies on how to achieve or maintain a healthy blood sugar range and prevent complications.

Diabetes Empowerment Education Program (DEEP™) - DEEP™ is developed and owned by the University of Illinois Chicago. TakeCare is a fully licensed DEEP™ training facility. This course is a Diabetes Self-Management Training program that provides an indepth curriculum on diabetes management that has been shown to be successful in helping participants take control of their disease and reduce the risk of complications.

With these programs, patients are paneled to case managers who will coordinate care with their Primary Care Providers. The coordination includes a quarterly extraction of HbA1c testing results to monitor patient progression and to review overall improvement of uncontrolled and controlled diabetes populations.

Verification Access

You can advantage of the tool to reduce patient wait time during eligibility and benefit verification by enrolling in TakeCare's Provider Portal.

To access the portal, your facility must identify a "Security Administrator". The Security Administrator can be your clinic manager or IT personnel. This function allows your security administrator to create the "End-User" accounts for your



facility. The End-User can navigate through the system to obtain necessary information of the TakeCare members plan coverage.

Clinical Quality: Healthcare Effectiveness Data and Information Set (HEDIS®) Audit

As required by the Centers for Medicare and Medicaid Services and the Office of Personnel Management (OPM), as a contracted carrier of the Federal Employees Health Benefits Program, TakeCare Health Plan is conducting its annual Healthcare Effectiveness Data and Information Set (HEDIS®) audit. HEDIS® is developed and managed by the National Committee for Quality Assurance (NCQA) and is used by more than 90% of America's health plans to measure performance and effectiveness.

Part of the HEDIS® audit process is to obtain pertinent medical information through medical record review. Over 500 TakeCare members' medical records that were statistically selected from our member data base will be abstracted and reviewed. If records from your facility were selected, our HEDIS® clinical review team will be contacting your office to schedule our onsite visit date and provide you with a list of TakeCare members' records that have been selected for review. The onsite record reviews will begin on *March 1st until April 16th*.

To increase access to testing and services relating to COVID 19 and fight the spread of the disease, we've updated our coverage policy to cover the following services:

Effective April 1, 2020, TakeCare will cover COVID 19 testing at 100% through Diagnostic Lab Services ("DLS") for Persons Under Investigation ("PUI"), i.e., individuals with mild symptoms that

meets the Public Health priority criteria and/or individuals not exhibiting any symptoms but had closed contact or were exposed to a positive COVID19 individual as evaluated and determined by a licensed contracted physician. COVID 19 testing specifically for work, travel or pre-operative purposes are NOT covered by TakeCare and shall be paid by the member.

Please note that the COVID-19 test and associated visit are covered at 100% under the member's preventive care benefit when using innetwork providers provided these tests and visits are not covered by the Guam and CNMI Public Health System.
