Performs case management process of assessing, planning, implementing, coordinating, monitoring and evaluating available health care resources under the health plan for the promotion of health, prevention of disease, management of chronic diseases and complex medical illnesses. Determines medical necessity and length of stay based on the consistent application of decision support system and communicates decisions to providers and patients. Initiates and coordinates discharge planning with physicians, members, families, caregivers and ancillary providers to support continuity of care needs. Identifies and refers catastrophically and chronically ill patients to case management when appropriate. Accurately and timely complete documentation in assessment report, database notes and other forms of statistical recordkeeping.
